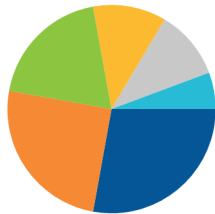
Fund Overview

The Equitable Life Active Balanced Portfolio Select will actively manage allocations between multiple asset classes based on the relative attractiveness of each category based on market conditions and the portfolio manager's expectations for that asset class. The portfolio manager may use a combination of fundamental and technical analysis in addition to quantitative measurements to establish the positioning bias of the fund. Exposures to particular asset classes will be achieved primarily through the use of exchange traded funds where a suitable vehicle is available.

The objective of the fund seeks long-term capital appreciation and income by investing in a diversified portfolio comprised primarily of fixed income, equity and real estate related investments. The portfolio, at times, may assume limited exposures to commodity related investments or other alternative asset classes.

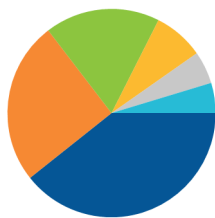

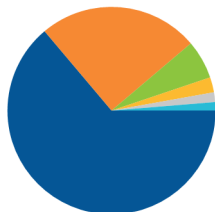

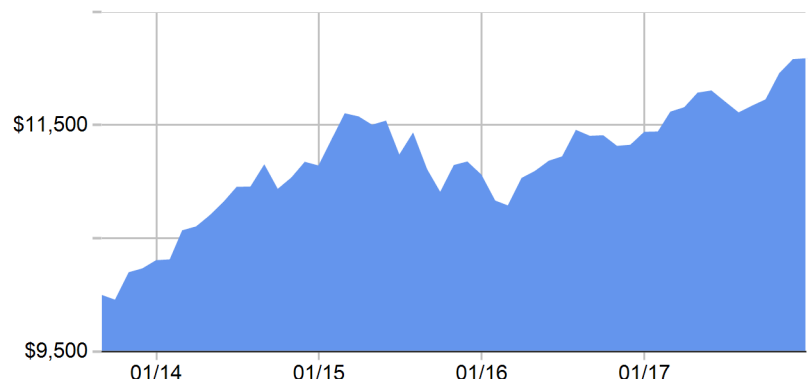
